## Self-Determination Housing Project of PA Inc.

- SDHP Inc. is a statewide non-profit organization founded in 1994 that works to expand housing options for people with disabilities and older adults in Pennsylvania.
- Goals
  - To bridge the information gap between the housing and disability/Older Adult communities
  - To promote state and local partnerships and coalitions that enable people with disabilities/Older Adults to choose and control their own housing
  - To increase the stock of affordable, accessible integrated housing
  - To expand access to public and private housing programs for people with disabilities/Older Adults

## PA Accessible Housing Program (PAHP)

- Enable low and moderate-income persons (under 80% AMI or 235% FPL, whichever is higher) with permanent disabilities to make their current home more accessible.
  - Owners & renters eligible, but only for home mods, not rehab like CDBG
- SDHP provides: (for 29 out of 67 counties)
  - Home modification assessments and recommendations
  - Modification specifications and hiring of contractors
  - Construction management
  - Final inspections and close out
- Must have permanent disability that leads to limited access to property, cannot be in the process of foreclosure

#### Information & Referral

- Connections to Services & Resources for Housing & Maintaining Independence (waiver, mods, assistive tech...)
- Not Consumer Facing work only with Social Service or Housing Providers due to size of area

#### • Education/Advocacy

- Presentations Affordable Housing Basics, Fair Housing, etc...
- Trainings (PREP)
- Landlord Forums & Outreach

#### Coordination of Resources

 Resource Clearinghouse for Older Adults and People w/Disabilities for housing and housing supportive services

## **RHC Roles with Landlords**

- Market vacant properties to Older Adults & Individuals with Disabilities
- Guidance on making units accessible
- Maintain list of accessible units in community, vacant or occupied (www.pahousingsearch.com)
- Provide resource connections to landlords for tenants
- Answer Fair Housing Questions
  - Housing Equality Center of PA: www.equalhousing.org
- Educate on voucher options for rental payments
- NHT (Nursing Home Transition) Support

## Pennsylvania's Nursing Home Transition (NHT) Program

- Area Agencies on Aging and disability agencies assist older adults and adults with disabilities residing in nursing facilities to transition back to the community, the home of their choice
- Individuals typically receive HCBS to maintain independence
- Services can be paid by Medicaid, Medicare, state dollars, or private pay
- Cost effective: serve 2 people in community for every 1 person in an institution

### **NHT Success**

- PA's NHT Program has become one of the most successful programs in the country because of the focus on housing
- Several initiatives to increase access to affordable/accessible housing to individuals transitioning back to the community
  - Regional Housing Coordinator Program
  - NHT Tenant Based Rental Assistance (NHT TBRA)
  - PAHousingSearch.com
- In the last fiscal year, the program saved the Commonwealth
   \$200 million dollars
  - Avg. Nursing Home Cost 36k whereas for 60+ HCBS only 15k and for under 60, 29k
