Helpful Suggestions

It is very difficult and emotionally stressful for parents when their son or daughter has been diagnosed with a mental health illness. Parents' main concern is keeping their child safe while seeking the appropriate treatment. At times parents are faced with the difficult decision of taking their son or daughter to a hospital emergency room for a possible psychiatric inpatient hospitalization; or an out of home mental health treatment facility.

If your son or daughter should ever require a psychiatric inpatient hospitalization or an out of home mental health placement, it is important to be prepared in advance. The hospital emergency room, psychiatric hospital, and other mental health treatment agencies usually request similar information. Being prepared can help your child receive the appropriate level of care, and reduce the stress you may experience. **Keeping a file of the necessary information may be helpful.**

If you choose to share medical information with others remember that the information is private and confidential and should only be shared with individuals who are assisting you in the treatment of your child.

TIPS FROM PARENTS FOR PARENTS

- Keep a calendar of appointments. Be prompt and reliable. Missing or being late for appointments can give the impression that you are not committed to your child's treatment.
- Call prior to appointments to find out what records, information, insurance referrals, and prescriptions you will need for the appointment.
- Don't burn bridges! There is a difference between being assertive and aggressive. Try to keep your composure at all times for the sake of your child. If you feel that you may lose your temper at a meeting or appointment, take someone along who can help you keep your emotions in check.
- It may be helpful to seek the assistance of an advocate.
- Find a support system for yourself. Attend a local support group or network with a parent. If needed seek therapeutic support for yourself. This information can be obtained on the County website.
- Accept help from family and friends. If someone

- If you have other children, try to spend one on one time with them. Try not to spend all of your time on the phone, online or talking about your child's diagnosis.
- Keep a current photo/photo identification of your child.
- Keep a current photo copy of information regarding your child's medical insurance plan(s) in your portfolio.

- Under Act 147 a parent or guardian can consent to outpatient mental health examination & treatment for minors 14-17 years of age.
